#### THE VAE: AN INDIVIDUAL RIGHT



- Registered in the work code
- Registered in the Education Code

« Any person involued in the active life has the right to the free validation of her / his assets in order to obtain a diploma. »

#### THE VALIDATION OF THE ASSETS...



- Acknowledges the skills obtained in the same activity field during a minimum period of 3 years,
- Allows the obtaining of some tests exemptions for the acquirement of a diploma.





## GREETING – INFORMATION - ADVICE



 Collective Information meeting and individual interview which allows an analysis of the project and the advice about the choice of the diploma.





#### THE CIVIL SERVICE CHECKING



#### **Nature of activities**

 Paid, unpaid and free activities directly related to the contents of the diploma can be taken into account.

#### **Duration of the activities**

 The minimum duration of the required activities can't be less than 3 years.





#### THE ATTENDING OF THE CANDIDATE



#### **OBJECTIVE**

- leading and avising her / him to describe in a file all the tasks and professional activities.
- preparing her / him to an interview with a jury.

#### **MODALITIES**

- Individual Interviews
- Collective methodological workrooms
- Personalized continuation of the candidate training





#### THE ATTENDING OF THE CANDIDATE



#### PERSONS CONCERNED

- VAE Experts: teachers, professionals
- VAE Councellors



#### THE CERTIFICATION



A jury will pronounce its judgment on the file given by the candidate







The president: an inspector, a professor or an professional according to the level of the diploma.

Teachers in the general and professional domains of the diplomae.

Professional employees and employers in the domain of the diplomae.



#### THE INTERVIEW: WHEN?



- It is organised:
  - when required by the jury
  - when required by the candidate





#### THE INTERVIEW: WHY?



An interview with a jury allows:

- The candidate, to explain clearly and to finish off all the information contained in her / his file.
- The jury, to check the genuineness of her / his statement.



## THE INTEVIEW: HOW?



- The interview is based on an exchange about the professional activities described by the candidate. In any case, it can't become an oral questioning on her / his assets.
- This interview is prepared and led by the jury the previous analysis of the file of the candidate before the interview.
- The duration of this interview takes place, on an average, between twenty and fortyfive minutes.



## THE JURY:



The deliberation is led around a global of the talent of the candidate:

- The jury must make sure that the activities done by the candidate gave her / him the possibility to acquire the khnowledge and to use the skills defined by the contents of the diploma.
- The decision of the jury will turn a complete or incomplete validation.







- To explain and have the members of the jury understand the undertaking and the objectives.
- To evaluate statements
- To evaluate skills of all fields and the assets used by the candidate in these professional activities.
- To take into account the social, cultural and personal evolution of the candidate.





## THE NATIONAL GUIDANCE OF THE VAE DEVICE
