





CITI-VAL project REPORT on E1/M2 (PSG 1) and Action note May 02-04, 2017 – BUDAPEST (Hungary)

The note of the 2^{nd} CITI-VAL meeting is an action note rather than a full chronological record of all the discussion at the meeting. It highlights the main issues discussed and the key actions to be undertaken prior to C1 from May 15 – 19, 2017 in ALMERIA (Spain).

Three strong periods during this transnational partner meeting in Budapest

As planed in the original application, Budapest was programmed for **E1 (academic symposium)** to disseminate the crossed analysis as a state of arts from the collection of data (O1) of pedagogical resources already used by teachers in prison teaching inmates in the field of **CITI**zenship as well as civic and moral **VAL**ues.

It was planned too to be time to visit the prison of Tököl.

M2 transnational meeting (including the 1st Project Steering Group -PSG-) was planned to be aggregated to the two prior strong times.

It takes place from 9:30 to 16:30 in the faculty of law enforcement at Budapest Police Academy.

More than 200 invitations were sent by FORESEE as hosting organization to Hungarian local guests (all Prison Services, Correctional Institutions, Ministry of Interior, Civil Services, National Institute of Criminology) and 80 actually attended E1, joined by 42 students of NUPS (122 in total).

Several interventions took place and the E1 strong points to be disseminated are the following:

- ♣ Prof. Dr. Klára Kerezsi (Senior Research Fellow, Chief Counselor of National Institute of Criminology, Head of NUPS Doctoral School of Police Sciences) who insisted on the fact that CITI-VAL must not be considered as a LifeLong Learning (LLL) project as so numerous others but in its main purpose as a very innovative programme addressed to juveniles and young adult inmates mainly not educated (as often early school leavers) who never received any educative rules focusing on civic and moral values as well as citizenship behaviour.
- Col. Attila Juhász (Associate, Heves County Correctional Institution) presented on successful reintegration programs and how these were executed in Heves County Correctional Institution. Life in prison shall approximate as closely as possible the positive aspects of life in the community, and all detention should be managed to facilitate reintegration into free society. The colonel insisted that prisoners necessarily should be given an adequate level of human and social interaction. Prisons face a lot of challenges these days (overcrowding, radicalization, inclusion of civil society, inclusion of restorative justice elements) and with consciously organized programs and educative elements the motivation in prisoners can be raised and kept.
- ♣ Gergely Fliegauf (Office of the Commissioner of Fundamental Rights) The Head of OPCAT NPM Department emphasized the importance of human rights in prison as these are one of the key elements to the problems already there not be escalated and be even deeper. If the conditions are acceptable and human rights kept as one of the most important issues in prison then feeling of despair and fear can diminish. G. Fliegauf emphasized the role social responsibility and the fact that human rights violation harms the society, too, after release.
- Péter Ruzsonyi Dr. major general (NUPS, Head of Department of Corrections) Prof. Dr. Péter Ruzsonyi introduced the university level education of correctional officers. While in the past correctional officers did not exist now is the time to educate and train them in a way that they can help imprisoned people on their way of reintegration. As correctional officers in Hungary provide for a great deal of educational duties in prison, training them the highest level possible can add to a well-being of inmates.
- Márta Fekete Dániel Somoskői (NUPS Department of Behavioural Sciences and Methodology) presented the results from the CITI-VAL data analysis show that the pedagogical resources collected by all partners light up already some common practices but also a lot of differences due to various criteria such as national culture, religion and how citizenship value education is addressed (in what stage the education of this particular notion is at) in different places. The Hungarian team found that those pedagogical programs where less teachers were involved were more successful and they believe this is due to the need for stability among inmates.







Visit of the prison of Tököl (May 03, 2017)

It takes place on May 03, 2017 from 9:00 to 14:00 (including the lunch prepared by inmates and offered by the Governor of the prison), and was followed by the start of M2 transnational meeting from 14:00 to 16:00

Feedback from prison visit

- The prison for adults hosts 800 inmates while the one for juvenile welcome 90 in this moment. Tököl also is the central hospital for all Hungarian prisons with 250 beds (including all medicine specialities such as gynecology, surgery,...). While the prison for adults and juveniles only welcome males, the Tököl national prison hospital (250 beds) receives male and female inmates (one special unit for VIH exist that actually hosts 1 inmate). If there is a real urgency, inmates go to local hospitals but if not so urgent, it's Tököl hospital that receive ill inmates from all Hungarian prisons.
- With reference to Hungarian laws, juveniles in prison are between 14 and 18 years old when sentenced (before 14 years old, they only could be sentenced by alternative measures). If they are sentenced when minors for a longer period than their 18 years old, they will stay in the juvenile area till 21 years old. As formal education is compulsory till 16 years old in Hungary, these young inmates fit the CITI-VAL target group.
- The prison is also the place where Duna Papir Ltd (Paper factory) allows inmates to be trained and to get experienced in jobs for their further reintegration.
- Governor says that a majority of incarcerated juveniles and young adults unfortunately grow with references to NO RULES (families have their own anteriority in prisons too. For example, one baby born in prison already stayed several times into juvenile section and is presently hosted in the adult prison) and that CITI-VAL goals fully correspond to the priority needs of these young prisoners.
- These juveniles receive empirical education from civilian teachers from Ministry of Education who work part time in prison. CITI-VAL partners meet 2 of these teachers who declared to be interested to test the pedagogical sequences that will be produced in ALMERIA (C1)







- With the help of integration officers these juveniles, on a voluntary basis, are invited to get involved in preparation of action for restorative justice but also to participate step by step to activities that will help them to develop sense of success (for example, drawing the right side of brain in 3 days, dropouts groups for theatre performance, visits to zoo, attend a film at cinema in city -1 inmate / 1 prison staff with a maximum of 6 to 10 juveniles or young adults in civilian clothes for both-).
- Juveniles are trained to gaining experience with sense of achievement,... so to change pattern. Sentences for juveniles are from 1 month to 15 years with an average of 5 years for homicides. On a voluntary basis they can attend school 20 hours a week and sport is compulsory (if health is OK). For juveniles not yet sentenced, cells are closed 23 hours a day so this does not allow them to attend courses (once sentenced, cells stay opened).
- For what concerns foreign inmates, there are only 15 among 800 adults and none among juveniles (when we visited Tököl prison).

M2 transnational meeting and Project Steering Group Agendas

As previously wrote, CITI-VAL partners started M2 while they were still in prison. Work was follow too on the last morning (but we were obliged to postpone PSG meeting to ALMERIA because of a lack of time, even if individual financial meetings with Turkey then Spain took place at the hotel when back from the Tököl prison, at 5:00 pm on Wednesday May 03, 2017.



CITI-VAL partners started to debate on the common values they would like to keep as general guideline for the pedagogical sequences to work on in ALMERIA (C1) and it was decided finally to only keep <u>6 common values among the 7</u> partners already identified during kick-off in Bordeaux (M1).



Then starting from a draft the coordinating organization prepared before to come to BUDAPEST, CITI-VAL partners debate and work on the template for pedagogical sequence. This work started inside the prison but was still on going on the next morning (May 04, 2017) it's why we were obliged to cancel the PSG meeting and to organize two individual times on financial matters with Turkey then Spain at the hotel when back from the visit of Tököl prison, on Wednesday May 03, evening before dinner.

PSG meeting is now planned to be in ALMERIA (C1), after Tuesday afternoon work, on May 16 while teachers will prepare their meeting with inmates and prison teachers for the Wednesday.

CITI-VAL partners come to a common template after long debates and exchanges on pedagogical points of view and the following document was validated by the consortium so it is no longer amendable.
